Disability Rights NC created the following resources to help parents and guardians self-advocate for their child.

<u>Parents Together (Revised 2008)</u> is a manual developed for parents who have children who currently receive or need to request special education services. This 224 page manual covers topics such as early intervention, the evaluation process, IEPs, placement, transition, discipline, behavior intervention plans, seclusion and restraint, and conflict resolution procedures.

<u>Request for Internal School Investigation</u> is a sample letter parents can use as a starting point to write their own letter to request a school investigation after an incident of restraint and seclusion or a generally inappropriate response to behavior. **Requesting a Reasonable Accommodation from a School** is intended to address those school activities, programs or services that may not be covered by an IEP but may still be covered under the ADA and Section 504 of the Rehab Act. This document provides information on what may be covered and tips on requesting the accommodation. This may include accessibility, service animals, etc.

<u>School Sports & Kids with Disabilities</u> provides information on what a school must do to ensure opportunities for participation in sports and how a parent may advocate for a child to be involved in sports.

<u>After High School</u> provides information to a young adult about their rights regarding a transition plan, some basic employment information and additional resources that may help them transition from school to work.

# **NC Department of Public Instruction Resources**

The Exceptional Children Division of the NC Public Instruction has resources that parents of children who receive special education services may find helpful in advocating for their child. Disability Rights NC's Parents Together is intended to be used in conjunction with the information found in the following two documents:

- <u>Policies Governing Services for Children with Disabilities</u> sets out the policies a school system is supposed to follow in providing special education services, including information about the procedures, timelines, and enforcement mechanisms.
- <u>Procedural Safeguards: Handbook on Parent's Rights</u> is the full explanation of legal rights (procedural safeguards) that is required to be available to parents under the IDEA and accompanying federal regulations. This document explains consent, notice, evaluations, access to records, state complaint procedures, due process, etc.
